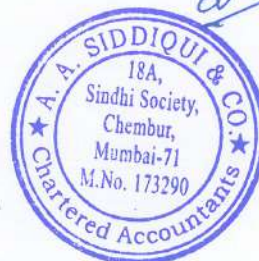
Managements Responsibility for the Financial Statement:
